## **General Ice Rules**

- 1) All skaters shall adhere to ice etiquette in a polite and mannerly fashion.
- 2) The ice monitor is in charge of the session and empowered to conduct the session in a manner consistent with good skating practices and will have total and complete authority regarding the interpretation of the ice rules.
  - a. No speed skating, tag, horseplay or rough play allowed at any time.
  - b. No hockey sticks or pucks are allowed on any session
  - c. No verbal abuse of other persons during any ice session.
  - d. No physical abuse of other skaters.
  - e. No physical abuse of the rink, ice surface, boards, benches, etc.
  - f. No congregating in groups on the ice during any ice session.
  - g. No standing at the barriers or on the ice surface when not skating. Skaters should leave the ice surface to hold conversations if not skating.
  - h. No skating in groups during any ice session.
  - i. No coaching by parents or non-approved coaches.
  - j. No blocking the entrance to the ice surface by skaters or spectators.
- 3) Upon arrival, skaters, whether contracted or walk-on, are to check in with the front desk to receive a wristband. The wristband will be placed on the skater's wrist. Parents will not be able to pick up the wristband for their child.
- 4) All sessions shall be limited to the amount of skaters as stated on the ice application.
- 5) The ice monitor or any BSA employees are authorized to order any person from the ice for cause.
- 6) **Music Rules**
  - a. Skater's CD's should be placed in the time keeper's box and placed in a line to be played.
  - b. Tapes will be alternated by those in a lesson and those not. Under no circumstances will Coach-requested tapes be played back to back.
  - c. Any skater who does not wish to skate their program when called will have his/her tape placed at the end of the line.
  - d. It is the responsibility of the skater to provide working CDs at the beginning of the session.
  - e. Skaters are to wear the bright colored vest provided by the rink while their music is being played.
  - f. All skaters shall give way to those performing their programs to music and wearing the vest. Skaters will also be courteous and yield where possible to those in lessons.
  - g. Competitors do not have priority
- 7) Spins shall be done in the middle of the ice surface and jumps shall be done at either end of the ice surface except in cases where program practice necessitates their placement elsewhere.
- 8) Appropriate skating attire will be worn at all skating sessions. Loose clothing or excessive jewelry that may jeopardize skating safety should not be worn. If attire is deemed inappropriate by the ice monitor or a BSA employee, the skater may be asked to leave the ice.
- 9) **Walk on skaters**
  - a. Walk on skaters must check in and pay at the front desk to receive a wristband and receipt before skating.
  - b. Walk on skaters must present to the ice monitor the session wristband.
  - c. If a session is full, walk on skaters will be turned away.
  - d. Walk on skaters must pay the walk on price even if they have contracted for other skating sessions.
  - e. Walk on skaters must follow the same rules as contracted skaters.
